

Important Information on the proposed LGBTQ+ privileged class ordinance

- Even if you do not live in Westerville, it will affect you if you visit Westerville, do business in Westerville, or do business with Westerville.
- It is called a nondiscrimination ordinance, however it is a discrimination ordinance to allow the government to discriminate against you if you do not believe in and follow the LGBTQ+ radical agenda.
- It has *not* been pushed by Westerville residents. It appears to largely have been orchestrated by outside agitators working with one or two council members.
- It is not needed. One council member cited a case that occurred almost 70 years ago in another country as justification.
- It is not equal rights, it is creating a LGBTQ+ “protected class” which is a “privilege class”.
- It is not biblical. Sin is elevated. Those that oppose sin are discriminated against.
- It is not constitutional. They want to enforce this ordinance via Star Chamber courts. I.E. No trial by jury, no trial by your peers.
- It is not fair. Webster defines “fair” as just, equal, and equitable. But it will create two classes, the LGBTQ+ privileged class and the non-LGBTQ+ peasant class. The two classes will not be equal.
- Vendors who do not support the LGBTQ+ privileged class will likely be shut out of business with Westerville.
- It is not safe.
 - Do you really want your daughter, your granddaughter, your wife, etc. to be subject to a strange man entering the women’s restroom? And if you try to stop the man from entering the restroom, you are the criminal.
 - Every time you are in Westerville, do you want to have to check the women’s restroom to see if a man is in there? And after a long period of time, you ask the man to leave and you are the criminal.
 - But you say, no jury would convict me. Well under the current plan, you don’t get a jury trial. You are “tried” by members of the privileged class who do not even live in Westerville.
- Do not be surprised if, after the ordinance is passed, non-conforming vendors / churches are forbidden from utilizing Westerville rental facilities such as pavilions, party rooms, etc. After all, you wouldn’t want something said at a church gathering in a park that offends the “privileged class”.
- Do not be surprised if, after the ordinance is passed, non-conforming vendors / churches are forbidden from 4th Friday, the Farmer’s market, 4th of July parades, etc.
- It is a divide and conquer strategy. They will “exempt” churches and church schools for *now*; however, it is clear they want to go after them later. Even now, it is unclear what exactly “exempt” means.
